David Gohring was not present to give the treasurer's report but had given the information to Kevin Clark. Kevin shared that the Hutch Swap meet had been successful. The club sold \$385 worth of goods. It cost us \$160 for our booth space so we netted \$225 for our club. Kevin also thanked John Sutter for all his work at the swap meet. Then Kevin shared that we have sold 527 tickets for our BBQ grill so far. He asked us to keep pushing the selling of the tickets. Then Kevin shared our bank balance is \$6,000.

Kevin asked for an update on Richard & Robin Bartel. Steve shared that they are both in good spirits and are healing. Richard is able to get in and out of the house by himself now. He still can't drive although Robin has started driving some. Robin has started to work from home now but her hand problems still persist. She is waiting for care on her hand still. Richard is getting OT and PT at his house. He has also replaced his truck that was totaled in the accident. Becky passed around a thank you note that Richard & Robin had written to the car club.

Kevin shared that the last meeting that was held at Don Hatten was a success and that Don Hatten has invited us back whenever we need to use the facility. The only drawback is that there is not an elevator to get to the 2nd floor where we held the meeting. Kevin shared that Don Hatten had contacted him about having some people participate in their Trunk or Treat event on Halloween evening. The dealership had room for 4 cars to participate. Kevin called some of the club members and easily got 4 people to participate. They took some of their own candy and Don Hatten also gave them candy to distribute. The dealership said to plan for 1000 children to come through. Kevin was pleased that our club had prime spots in bays 1-4 to showcase our cars. Steve was planning to get the money and take it to the bank and get a cashier's check to take to the Fire Department. He asked if we had a card that everyone had signed and if so he would take the money and the card to the department. Larry suggested that we give them the cash instead of a cashier's check. Steve thought that sounded good. He mentioned that it is a volunteer fire department and that they need donations to keep working. Steve said if the weather is good he is planning to take his motorcycle and deliver it in person to them.

Mick mentioned that he and Larry had gone to the Cars & Coffee event recently. He said he was pleased with the location and impressed at how they got between 500-600 cars in and out. He said he thought this was an excellent location for our Regional event.

Dec. 16, 2023 at 5 PM will be our Christmas Party at Mike's garage. WACO will furnish the meat and club members will provide the sides. Jack said he would do a ham and a turkey. Kevin will do another type of meat. We will also have our traditional gift exchange and our Bingo game and some other games. Kevin asked if anyone was willing to run the Bingo game. Several club members gave Doug a hard time about not doing it this year but Doug said he had done it the last 2 or 3 years and wondered if someone else would like to do it. Kevin also asked if anyone would be willing to come up with another game for that evening. He also mentioned that Becky, Jack and Teresa had volunteered to purchase gifts for the games and also the kid's gifts. Becky volunteered to look through her file folder and find an appropriate game for the club. Doug then consented to running the Bingo game again this year. So those two things are taken care of.
